Somethings that I wanted to mention:</p> <ul style="list-style-type: none"> • There are several new initiatives listed in the Accomplishment Report and on the Financial Dashboard. • We should take great comfort knowing that we have ongoing Assessments with improvement plans, policy updates and Strategic Plans • We have our Articles of Inc. for YVEDDI Weatherization, Inc. • We have Board Fundraising in process and band sponsorships that total \$3,750 • We just had our most successful United Fund Workplace Campaign raising a grand total of \$10,909 by YVEDDI Employees. This is truly amazing given that our employees average \$12.71 per hour. • In the last 2 weeks, we've had grantor monitoring from ECMHS, CSBG, DV/SA, and Senior

He also spoke to Eddie Harris who's agreed to donate a pendant and bracelet from Harris Leather and that Walmart will be making a donation after the first of the year.
